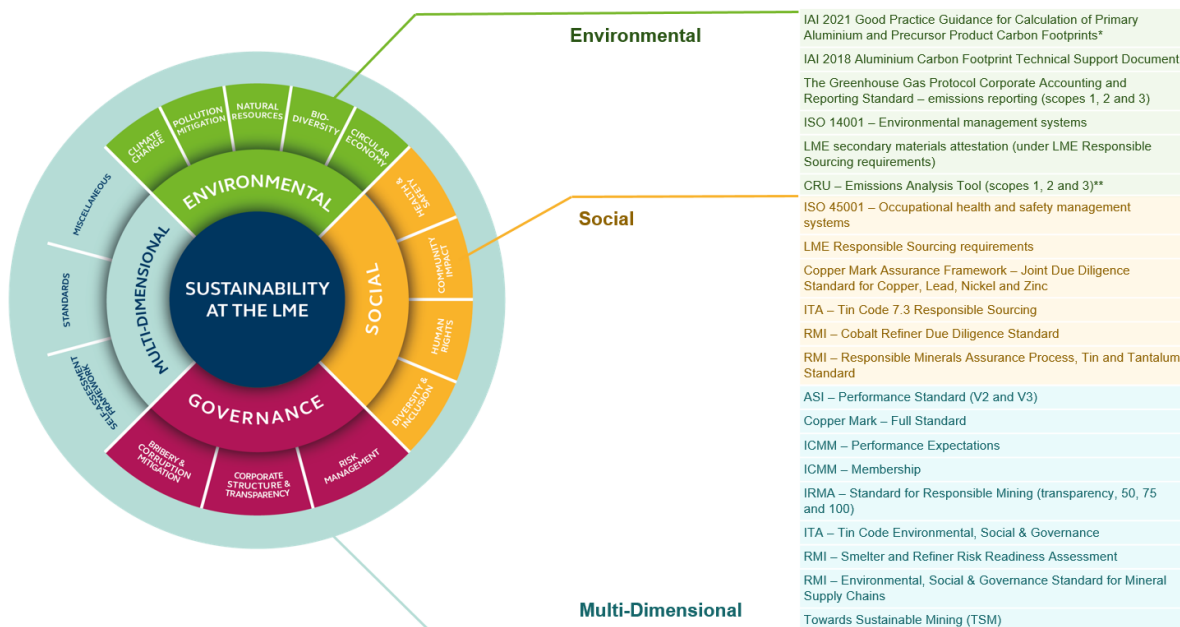
1 Introduction to sustainability on LMEpassport

LMEpassport allows LME-listed brand producers to highlight the [sustainability credentials](#) and metrics related to their metals. There is a wide range of approved disclosures that can be used to disclose.

These disclosures are categorised by four areas:

- **Environmental** – including but not limited to carbon emissions, biodiversity, recycling, reducing and mitigating polluting activities
- **Social** – including but not limited to human rights, impact on communities, health and safety
- **Governance** – including but not limited to corporate structure, risk management and bribery and corruption controls
- **Multi-dimensional** – those certifications / metrics that encompass aspects of all or some of E, S and G

Current examples of certifications / metrics available on LMEpassport are below:
