Subject: UPDATES TO LME GROUP FEES AND CHARGES 2022

## **Summary**

 This Notice sets out certain updates to the fees and charges for LME and LME Clear (together the "LME Group") that will take effect from 3 October 2022.

#### **Defined Terms**

Capitalised terms not otherwise defined in this Notice shall have the meaning ascribed to them in the LME Rulebook.

#### Position transfers

- 3. Certain position transfers and other administrative transactions may be eligible for a fee discount or waiver. The eligibility is set out in the LME Group Position Transfer Procedure.
- 4. With effect from 3 October 2022, the LME Group Position Transfer Procedure has been amended to define Ordinary Position Transfers and Extraordinary Position Transfers.
- 5. Ordinary Position Transfers will be eligible for a fee cap amounting to US \$12,000 per ultimate beneficiary plus 20% of the equivalent fee if the transfer had been conducted on LMEsmart, up to a maximum of US \$60,000 plus 20% of the equivalent fee if the transfer had been conducted on LMEsmart.
- 6. Extraordinary Position Transfers will be eligible for a fee cap amounting to US \$12,000 per ultimate beneficiary up to a maximum of US \$60,000.
- For further information please refer to the LME Group Position Transfer Procedure which may be amended from time to time.

#### Market data: Historical data

- 8. The annual order and trade history service will be withdrawn effective immediately.
- 9. LMEselect historical tick data will be made available to certain users as part of a pilot initiative with no associated charge.

### MiFID II requirements

10. Sections 7-9 of the Schedule of the LME Group fees and charges explain how the LME's fees comply with the requirements of the relevant UK law corresponding to MiFID II.
