Guidance Notes for Applicant Producers

Registration of High Grade Primary Aluminium Brands Guidance for Applicant Producers

1. Primary Aluminium producers wishing to apply for the listing of their brand by the LME will only be considered provided that they satisfy the following criteria (the “Core Listing Requirements”):
 - (i) The producer has been in business for at least 12 months.
 - (ii) The production plant has been in production for a minimum of 12 months or, if in the opinion of the LME Aluminium Committee adequate production capacity utilisation and satisfactory quality has been achieved at an earlier date.
 - (iii) Has a capacity to produce a minimum of 25,000 metric tons per annum of Aluminium.
NB. *A production plant is defined as an integrated aluminium smelter with an associated casting plant producing a brand of aluminium of consistent assay, quality and identity. Exceptionally, it may be permitted that a “stand-alone” casting house may be considered for listing subject to any additional conditions that the LME may introduce.*
2. The producer is required to advise the LME in writing of the name of the Category 1-5 Member Company who will be processing the listing application (see Rule Book Part 7, Rule 1). Thereafter, all correspondence will be via the selected Member Company. A list of Members Categories 1-5 expressing a general willingness to assist producers list their brands can be found here:-

3. Production from more than one production plant must be separately listed. Each production plant must use a different brand name.
4. The application is in two stages and all documentation must be submitted in English.
5. The LME and LMEC reserve the right to discuss without restriction any information provided with any regulatory body; any third party provider of KYC, screening or other monitoring services; or any other persons or organisations, as the LME/LMEC may in their absolute discretion decide, and to make such other enquiries as they think fit (including using the information provided by the Producer in such enquiries).

Note: The LME has introduced responsible sourcing requirements for all LME listed brands; compliance with the first phase of requirements needs to be met on 30 June 2022 and compliance with the second phase of requirements needs to be met on 31 December 2023. Stage One

The producer is to supply the following information in a letter on their headed notepaper addressed to the LME (the "Application Letter¹"):

1. The name of the LME Member processing the application.
2. The full name and address of the producer to be listed by the LME.
3. Brief details of the history of the producer.
4. Details of the ownership of the producer.
5. The address of the production plant.
6. The first date of production of the plant.
7. The name of the brand the subject of the application.
8. The first date of production from which the producer guarantees the brand as meeting specification.
9. The design capacity.
10. The current annualised use of capacity.
11. The monthly production figures for the previous 12 months.
12. The shapes to be listed; ingots and/or sows and/or T-bars.
13. The names of two Testers from the List of Approved Testers provided at the end of these Guidance Notes which the producer intends to use for testing (Stage Two). Evidence of the Testers' willingness to test is to be submitted. Prior approval will be required from the LME Aluminium Committee to use the named Testers.
14. The names of two LME Listed Samplers and Assayers (LSAs) to carry out the assessment of the quality of the application brand (Stage Two).

At this stage, it is the Producer's responsibility to ensure that the information complies with the Special Contract Rules for Primary Aluminium, LME Rules Part 6 and to ensure that no testing is to take place until approval to do so is given by the LME.

¹Note that the signatory and their position within the producer company must be shown on the dated Application Letter



The following information (the “Additional Listing Requirements”) is to be provided by attachments to the covering Application Letter.

- A. The following financial information:
- (i) The last three consecutive profitable externally audited financial statements of the producer, where available;
 - (ii) In the event the producer cannot provide three consecutive profitable externally audited financial statements, the parent company must provide three consecutive profitable externally audited financial statements and a signed Letter of Support² regarding the financial standing of the producer³
 - (iii) Confirmation that there has not been any restructuring of the producer over the last three years and no ongoing restructuring; and
 - (iv) Evidence that the capital net worth⁴ of the producer is a minimum of US\$2 million.
- B. A copy of the incorporation certificate of the producer.
- C. Details of the product as follows;
- For ingots:
- (i) Photographs of an ingot product showing the brand, grade and production cast reference and any other symbols on the metal.
 - (ii) A copy of any label used which must be plasticized.
 - (iii) Photographs of a strapped bundle from top and side dimensions.
 - (iv) Drawings of an ingot and a bundle with all dimensions in mm and weights in kilos and stating the number of ingots in a bundle. Also the producer is required to state with the drawing of the bundle the following phrases;
 - (a) Each bundle is securely strapped with material protected against corrosion and of sufficient strength and fixing to permit safe handling by fork lift truck without bundle distortion and breakage.
 - (b) The bundle size and shape is suitable for safe and secure stacking.
 - (c) The bundle assembly and security is such that on removing the security straps it remains an integral free standing bundle.

² The LME shall provide the Letter of Support to the producer.

³ The LME reserves the right to require a signed Letter of Support from the parent company of a producer in such circumstances regarding the financial position of the producer as it, in its absolute discretion, considers appropriate.

⁴ The capital net worth of the producer shall be determined on the basis of the permanent capital plus additional capital disallowables. In particular, permanent capital shall be issued and fully paid ordinary shares, issued and fully paid preference shares, share premium and other reserves not available for distribution. A deficit in reserves available for distribution will be deducted when calculating permanent capital. Additional capital shall be considered other equity reserves (distributable or otherwise) and profit and loss reserves. Further, disallowable items are considered intangible fixed assets such as goodwill, development costs etc, investments in subsidiaries and/or other group companies.



For T-bars and sows:

- (i) Photographs of the shape(s) from top and both side dimensions showing the brand, grade and production cast reference and any other symbols on the metal.
 - (ii) Drawings of the shape(s) showing all dimensions in mm and weights in kilos.
- D. A Letter of Undertaking dated and signed on behalf of the producer in the form shown at the end of these Guidance Notes.
 - E. An outline of the production process including a process flow diagram.
 - F. A production site plan/diagram.
 - G. A paper giving the sampling and analytical regime and advising if any aspect of this work is outsourced. Show the detection levels used for determining impurities.
 - H. A schedule of the production batch analysis data for the previous three months.
 - I. A copy of the normal dated Certificate Analysis which must include the English language, the name of the producer, the name of the brand and the production batch reference. Note that Certificates of Analysis provided by Listed Producers must at all times show compliance with LME listed specifications by showing actual analysed content of the metal.
 - J. A copy of the current ISO 9001 Certificate or, alternatively, that of ISO/TS 16949.
 - K. Also at **Stage One**, payment of the fee for applying for the listing of an aluminium brand is required. The fee is US\$65,000 plus ruling UK VAT and it is non-refundable.

NB. *Value Added Tax (VAT): Under current UK legislation, the LME understands that LME members established in the UK submitting applications for their own production operations or for third party producers must pay UK VAT to the LME at the ruling rate at the time of application, regardless of domicile of the producer. LME members should only on-charge UK VAT to producers established in the UK. LME members not established in the UK making applications do not have to pay UK VAT to the LME regardless of the location of the production operations. This information is for guidance only and relevant parties should always seek their own advice in relation to tax matters. The LME will have no liability for reliance on the above.*



Stage Two

1. On receipt of all information the LME will respond to the application as follows:
 - (i) Request such additional information as required.
 - (ii) Approve or otherwise to proceed to testing with Testers mutually agreed and any production plant auditing.
 - (iii) Advise the tonnage for testing which will usually be 2 x 50 tons unless otherwise specified by the LME.
2. The LME will write directly to the Testers and LSAs advising them of their nomination and requirements for testing.
3. Sampling of test lots shall be carried out by an LSA at the Testers' works and/or if required, at the application producer's production plant. Samples shall be taken, divided and distributed in accordance with LME procedures which include supplying samples to a second LSA for analytical purposes to augment the analysis of the sampling LSA. The sampling LSA shall provide a sampling report covering all aspects of the test lots in accordance with LME instructions. The two LSAs shall provide analysis reports of the metal tested in accordance with the LME requirements for Primary Aluminium.
4. The producer is required to provide the LME with their analysis certificates for the production lots that are sent to the two Testers for evaluation.
5. The LME will receive all assay and sampling reports.
6. Production plant quality control auditing and the requirements for sampling and analysis of test lots will be at the cost of the producer. Selection of LSAs will be at the choice of the producer.
7. The Testers are required to supply a letter to support the application subject to their satisfaction with the brand under test.
8. The LME Aluminium Committee reserve the right to require that aluminium for testing is selected in a random manner by an LSA at the expense of the producer.
9. The LME reserves the right to require testing to be extended if, in its sole opinion, such action is necessary for evaluation of the brand.
10. On receipt of satisfactory reports from the testing fabricators and LSAs, the Aluminium Committee will make a recommendation to the LME Executive Committee that the brand should be listed as suitable for delivery against the contract.
11. The LME reserves the right to audit any producer's operations at any time prior to or post listing of a brand for verification of any aspect of the listing process.



From time to time the LME will request every producer having listed brand(s) of Primary Aluminium to re-affirm the undertakings originally given at the time of listing. Failure to comply with the undertakings or supply evidence of continuing compliance with the ruling specification and requirements may result in the delisting of the brand(s) concerned. If the producer fails to notify the LME promptly of any change in the information supplied with its original application, or if such changes are in the LME's view material, then the LME's Executive Committee may suspend the listing or delist the brand.

The listing of any brand is subject to the provisions of Rules 3 to 7 inclusive of Part 7 of the Rules and Regulations of the LME.

We further undertake that any change in ownership, financial status, production practice or any other material circumstance will be advised to the LME without delay and to comply with Rules 3 to 7 inclusive of Part 7, of the Rules and Regulations of the LME, any amendments thereto and any Notices issued by the LME.
5. This letter of undertaking shall be governed by English law. The courts of England shall have non-exclusive jurisdiction to settle any disputes in relation to this letter of undertaking.
